If we consider Indian legal scenario, the normally 6 to 7 lakhs (600 thousand to 700 thousand) cases where registered for 2-3 crore population.

So, in the growth proposition of our AJ Firm , in next 5 years span, the expected Associates numbers will be a bare minimum of 300 thousand, & the annual revenue after, all expenses is of 50 crores(500 million) to 100 crores (0.5 to 1 billion) , within Five years span. There are nearly 2.5 lakh cases / one crore population in average across world, where some

countries, crimes are not reported or the cases are settled under gun point in problematic regions.

To summarize, average 1 case per 50 people population are getting registered per Annum across world. Average 16 to 20 crore cases(200 million) are registered [conducting and also ongoing cases ,(excluding initial settlement cases)]across the world per Annum.
